Overall, NHLA helped 6,721 people, including clients, clients' household members and people who received referrals. NHLA focuses our efforts on cases involving clients' most basic needs, including housing, subsistence income, access to health care, and safety from domestic violence. At that time, all Board members are required to complete these forms, which are kept in the organization's records. Any new Board members who are appointed during the year are given copies of the policy and it is discussed during their orientation. As a result, there is a high level of awareness and sensitivity among Board members to any potential conflict. We have required this disclosure by Board members for a number of years, and as of 2012 we have extended this practice to key employees.
