Consumer Debt Collection/ Financial Exploitation:

- ♦ Harassing phone calls and/or letters from debt collectors
- ◆ Unfair and deceptive practices by debt collector
- ◆ Lawsuits filed by creditors or debt collectors
- ◆ Protected income exempt from collection: e.g. Social Security/SSI benefits, unemployment compensation, and more
- Improper use of an elder's funds or property
